**GENERAL FINANCIAL AID INFORMATION FOR SUMMER 2010**

- **Requesting Summer Financial Aid**
- You must be registered for summer classes, have completed the 2009-2010 Free Application for Federal Student Aid (FAFSA) and completed the 2010 Summer Application for Financial Aid.
- **Eligible** students will be awarded approximately 2 weeks after we receive this completed form.
- No requests for summer aid will be accepted after June 14, 2010.

**Eligibility**

- You must be enrolled in a minimum of 6 credit hours to receive loan funds.
- **Satisfactory Academic Progress:** If you were awarded summer financial aid and you do not meet Satisfactory Academic Progress standards after your grades have been reported for the 2010 spring semester, your **summer aid will be cancelled**. If your financial aid has credited your student account, the aid will be cancelled and the funds returned. You will need to make alternative plans to pay for your 2010 summer session tuition and fees. Please review AMC Financial Aid Standard of Academic Progress Policy.
